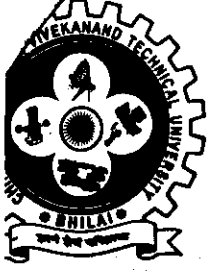
The institution has been found to be suffering from following deficiencies as observed by the Inspection committee.
